

Grapefruit League Baseball

Minor League Baseball offers the perfect environment for camaraderie. Enterprise Florida and other Team Florida partners hosted site selectors and corporate prospects at Grapefruit League ballgames in West Palm Beach, Vero Beach and Viera.

Daytona 500 & Coke Zero 400 Consultant Events

Enferprise Florida invited TVEDC to collaborate in welcoming site selectors and economic development consultants to Daytona International Speedway to experience the Daytona 500 from a VIP suite in February. In July, TVEDC hosted a group of economic development prospects to attend the Coke Zero 400. These guests enjoyed a three-day stay in Volusia County that included the NASCAR race, a tour designed to showcase the community, and receptions at Embry-Riddle Aeronautical University and Stetson University.

National Business Aircraft Association

The National Business Aircraft Association's Business Aviation Convention & Exhibition in Orlando was the year's most significant nationwide media event for the aviation industry. TVEDC exhibited with Embry-Riddle Aeronautical University, interacting with prospects from the public and private sectors.

DeLand Sport Aviation Showcase

The first DeLand Sport Aviation Show was a great success. It attracted aviation manufacturers, aviation services professionals, Experimental Aircraft Association members, media and government officials.







Competing on the global stage

TVEDC has identified worldwide opportunities that hold great potential for Volusia County. The community's global reputation in aviation and motorsports – and its allure as a leisure destination – command attention when the conversation turns to Volusia County as a host for business and industry.

Farnborough International Airshow

TVEDC and Embry-Riddle Aeronautical University teamed with Enterprise Florida to present at the Farnborough International Air Show in London. The event included an industry trade show with exhibits from the world's leading aviation and aerospace companies.

39th Annual Joint Meeting in Tokyo

The 39th Annual Joint Meeting of the Japan/U.S. Southeast Association and the Southeast U.S./Japan Association was held in Tokyo. This year's joint meeting included 30 key business, economic development, and government leaders from Florida. Some 250 participants from Japan and the Southeastern member states attended, according to Team Volusia President and CEO Keith Norden, who also chairs the Florida Delegation of the Southeast U.S. /Japan Association and has been engaged with that organization for more than 20 years.

Aviation and Aerospace Workshop in Tokyo

A Tokyo seminar focused on aviation and aerospace investment opportunities in Florida. The Japan External Trade Organization (JETRO) assisted in organizing a matchmaking workshop focused on aviation and aerospace. The seminar included presentations by TVEDC; Embry-Riddle Aeronautical University Worldwide; Enterprise Florida; Florida Power & Light; Space Florida; Space Coast EDC; and the Consulate General of Japan in Miami.

Hannover Messe

The Hannover Messe is the world's largest manufacturing trade show. Enterprise Florida invited TVEDC to participate, making Team Volusia EDC the only other Florida economic development organization represented at the show. More than 6,500 exhibitors from 90 countries participated in the event.

Quebec Classe Export

Team Volusia was invited to attend Classe Export and exhibit with the Quebec-Florida Chamber of Commerce in Montreal. TVEDC has worked closely with the Quebec-Florida Chamber of Commerce since 2013 when it organized and sponsored a Volusia County seminar/reception for its members during a TVEDC mission to Canada.

With several projects completed, 2016 was a banner year in our community. Thanks to the dedication and support of Volusia County Government and our cities, our stakeholders and economic development partners, hundreds of new jobs were generated and hundreds of millions of dollars in capital investment fueled our economy.

B.BRAUN MEDICAL COMPANY, a German medical manufacturer, has announced plans to make a capital investment of more than \$100 million and create 175 jobs.

DAVITA LABS plans to expand its DeLand complex with the construction of a new lab building and the creation of 100 new jobs.

HALIFAX HEALTH has announced plans to build a Medical Village with an acute care hospital in Deltona. The project could exceed \$100 million when fully built out.

THE DELTONA-DAYTONA BEACH-ORMOND BEACH AREA is recorded as having the nation's most improved local economy in 2016 as reported by the Milkin Institute's latest annual publication of the Best Performing Cities.

DAYTONA INTERNATIONAL SPEEDWAY completed its \$400 million Daytona Rising project, a total re-imagining of the complex, to become the world's first motorsports stadium.

ONEDAYTONA, an \$800 million, 300,000 square foot complex across from Daytona International Speedway welcomed its first tenants, Cobb Theaters and Bass Pro Shops.

BRANNON CENTER, a \$5.7 million, 13,900 square foot multi-use civic center in New Smyrna Beach has opened and already is booking a wide variety of events.

TANGER OUTLET MALL, a \$100 million destination retail center has opened with more than 75 outlet stores at its high profile location along Interstate 95.

JETBLUE AIRWAYS began nonstop service between Daytona Beach International Airport and JFK International Airport in New York City, with impressive passenger load factors.

EMBRY-RIDDLE AERONAUTICAL UNIVERSITY has begun construction of the 50,000 square foot Advanced Aeronadynamic Lab Building, known as the The John Mica Engineering and Aerospace Innovation Complex, the first component of the new ERAU Research Park.

STETSON UNIVERSITY'S STUDENT UNION & WELCOME CENTER, a 24,000 square foot structure in the middle of Stetson's historic district is now welcoming prospective students and their parents to campus, assisting current students and welcoming alumni back to campus.

MINTO COMMUNITIES has announced plans to build over 3,000 energy-efficient residences with an impressive array of world-class amenities and activities, all designed for the active adult lifestyle.

THOMAS W. STAED VETERAN'S MEMORIAL BRIDGE is under construction in downtown Daytona Beach and is becoming an instant landmark for the city, both for its architecture and its salute to veterans through the ages.









