# International Conference & Expo on Advanced Ceramics and Composites

TVEDC Vice President Chris Wimsatt did not have to travel far to man the organization's exhibit at this important high-tech trade show. Held at the Daytona Beach Hilton Oceanfront Resort and the Ocean Center, the event drew more than 1,000 delegates including 299 students, from 37 countries with about 50% coming from outside the United States. Programming included a symposium on ultrahigh temperature ceramics and a Pacific Rim engineering summit. Also attending the event were TVEDC President and CEO Keith Norden; **CEO Business Alliance President Kent Sharples** and Mary Garvin, the organization's Director of Business Development; and Brad Harris of the Volusia County Economic Development Division. Team Volusia and the CEO Business Alliance co-hosted a social event at the Streamline Hotel to welcome delegates to Volusia County.

### Team Florida takes to the ice

The economic development leaders of Team Florida welcomed prospects and corporate decision makers in Washington, DC to an exciting Washington Capitals hockey game. Prospects and guests were entertained at a corporate suite by Team Florida members including representatives of economic development organizations, utility companies, Enterprise Florida and other organizations.

This important annual forum was limited to economic development leaders including certified economic developers.

# Site Selectors Guild 2020 Annual Conference



Nearly 50 of the nation's leading site selectors gathered at the Site Selectors Guild Annual Conference in Atlanta in March. Site selectors and economic development professionals, including TVEDC President and CEO, Keith Norden. This invitation-only event is a highly coveted networking forum. The theme was Foreign Direct Investment, Global Trade and the Impact on Site Selection.

### SmallSat 2020

Silicon Valley was the setting for SmallSat 2020, the world's largest small satellite business conference. Within 10 years non-geostationary satellites, dominated by small satellites, will be responsible for the majority of the satellite industry's revenue.



This industry has a significant and growing presence in Florida's Space Coast and is expected to increase its footprint with investments in Volusia County. TVEDC Vice President Chris Wimsatt attended the event, where discussions of the latest technologies and market dynamics were hot topics. There was also a forum on understanding what it takes to secure market share and take part in the growth of small satellite industries.

### Commercial Space Symposium

TVEDC Executive Vice President Heather Shubirg attended this Washington, DC event along with Volusia County Manager George Recktenwald, County Council Member Deb Denys and Volusia County Director of Aviation and Economic Resources Rick Karl. The event was well represented by people and organizations serving the commercial space industries, including corporate executives.

### SATELLITE2020

This event brought the satellite-enabled communications ecosystem to Washington, DC for a global event on satellite technology. SATELLITE provides an essential forum in the ever-changing satellite industry including vital information about new end-user markets, applications and technologies including manufacturers, service providers and integrators. TVEDC Executive Vice President Heather Shubirg attended this event, which had to be cut short as the coronavirus crisis emerged as a threat to the United States.





### Annual Meeting caps successful year

More than 270 community leaders gathered at the Mori Hosseini College of Hospitality at Daytona State College to review and celebrate a

successful year of Team Volusia economic development activity. The "Sky's the Limit" program kicked off with a high-energy video and printed 2019 Annual Report, recapping the year and setting the stage for 2020. Special presentation was made by Team Volusia Treasurer John Olivari to George Mirabal, former president of the Daytona Regional Chamber, for his pioneering work in establishing Team Volusia in 2010. Keynote speaker Scott Henderson offered an overview of aerospace company Blue Origin and spoke of Volusia County's role in aerospace technologies and commercial space activity. Team Volusia Chairman Charles Duva, M.D. delivered a comprehensive look back and an insightful look ahead. He commented on companies that committed to Volusia County in 2019. They include Future Foods (meat substitutes); Loën Laboratories (refined products for people and animals; Smart Baking Company (smart nutrition food products); Arralis (high-tech communications and radar technologies); Extended Stay America (lodging for business travelers); 1Up Logistics ("last mile" distribution for Amazon); and Amazon.com (regional fulfillment center).
