Duke Energy Site Readiness Program

The Duke Energy Site Readiness Program began in 2005 in North and South Carolina and

Duke Energy Florida implemented the program in November 2012 following the Duke Energy/Progress Energy merger.

The Site Readiness Program is intended to identify, assess, improve and increase awareness of industrial sites in Duke Energy service territory, as well as to advance the state of readiness of these sites. These studies are conducted by nationally recognized site selection consultants who evaluate the sites and provide a final report on recommendations for the properties. To date, 34 properties have been evaluated in Florida.

Outreach 2020 Style



Maritza Martinez-Guerrero is an Associate Vice President for the Division of Government and Community Relations, and Director for the Office of Community Relations and Economic Development of UCF. A strotegic and trusted public affoirs executive, with more than 15 years of experience strengthening internal and external stakeholder relations in higher education.

Over the years, Martinez has represented the University on numerous boards and community-wide efforts, and currently serves on the boards of the National Entrepreneurship Center, GrowFL, National Center for Simulation, the Downthown Orlando Partnership, among others. Martinez received her bachelor's, master's and MBA from UCF.

Rear Adm. Paul Sohl (USN Ret) has been tapped to lead the Florida High Tech Corridor Council (The Corridor Council), an economic development initiative of the University of Central Florida (UCF), the University of South Florida (USF) and the University of Florida (UF) to attract, retain and grow high tech industry and innovation – and the workforce to support it – in a 23-county region spanning the state.

He holds a Bachelor of Science in aeronautical engineering from the Massachusetts Institute of Technology and a Master of Science in aeronautical and astronautical engineering from Stanford University. He later deployed to Afghanistan during Operation Enduring Freedom.
